7 STATEMENT ON INTERNALLY DISPLACED PERSONS

Marsabit County, Saku Constituency experienced inter-ethnic clashes which majorly affected two tribes in our great County- Gabra and Borana Communities during the 2018-2022 incidents which saw people displaced, lives lost, properties destroyed and livestock driven away from both sides as a result of the conflict.

The many displaced persons are in a distress state since there are no formal settlement for them after they deserted their homes to a safer place.

To this end, I seek a statement from CECM Administration, Coordination of County Affairs and ICT through the Chairperson of the Committee on Administration regarding the fate of the internally displaced persons within Saku Sub County following inter-ethnic clashes of 2018-2022. The CEC should;

- 1. State the number of IDPs from Gabra Scheme, Konso banchole, Isaqo Umuro, Sales Wako and Olla Dhaba Villages
- 2. Explain whether any humanitarian assistance was accorded to them
- 3. State whether there is any plan to resettle the displaced persons back to their lands now that the peace is restored
- 4. State whether there is any plan to rebuild the schools, Mosques, Churches which had been demolished during the conflict
- 5. Give the time frame, if any, when the resettlement and reconstruction will take place.
